PATH On-Site Instructor Workshop and Certification

In order to become a PATH, Int'l Certified Instructor, you must successfully complete the two phases of the certification process.

For additional information on this process, please refer to the PATH website at www.pathintl.org under Instructor certification drop down menu. Any questions regarding Phase One should be directed to the PATH office, any questions regarding Phase Two should be directed to PATH or MTRA (Marion Therapeutic Riding Assoc).

Phase One (PATH)

With submission of your Registered Instructor Certification Application form, an application fee, copies of current CPR and First Aid certification cards, and PATH membership number, you will officially enter into Phase One. Upon receipt, PATH will email you a Phase One Packet.

*Phase One Packet includes access to the following
Online components:*

- * Center Accreditation Training Course (CAT)
- * CAT Instructor Exam
- * Instructor self study course
- * PATH Reg. Instructor Open Book Exam

NOTE: you will have 6 months to complete the Phase One Packet. Please note that the CAT Course/Instructor CAT exam has a 60 day time frame and the Instructor self study Open Book exam had a 6 month time frame.



PATH On-Site Instructor Workshop and Certification

Phase 2 (MTRA)

Within 12 month time frame, you must complete all the components of phase Two:

* Complete 25 hours of practice teaching mounted therapeutic riding lessons under the guidance of or direct supervision of a PATH certified instructor.

*Attend a Registered Instructor On Site Workshop .You MUST attend PRIOR to the certification component.

*Successfully complete a Registered Instructor On Site Workshop.

If you are interested in attending the On-Site Workshop and or Certification please complete the attached form and registration check and mail to MTRA. For certification candidates, you will also need to include a copy of your Instructor-in Training status letter from PATH.

Candidates are registered on a first come first serve basis so early registration is recommended especially for certification candidates. **REGISTRATION DEADLINE is February 15, 2012**

Once registered, MTRA will send you a PHASE TWO PACKET. This packet will need to be completed and returned to MTRA with a copy of your NARHA membership card, and current copies of you CPR/First Aid certification (check exp. dates they must be current at time of exam!) **Phase Two forms must be in by March 2, 2012**

Also included in Phase Two packet will be suggestions for lodging and directions to the program.
